

2 main conclusions:

• Raise awareness of all the stakeholders on the benefits of creating electronic and standard versions of documents necessary for international trade.

• establishment of a single window to facilitate procedures, reducing time and costs of the transactions.

UN /Cefact Recommendation No 33

"a single window is a facility that allows parties involved in trade and transport to lodge standardized information and documents with a single entry point to fullfil all import, export and transit-related regulatory requirements; if information is electronic, then individual data elements should only be submitted once"

- Analyze critical points and issues in the Exp-Imp process
- Contribute to national and international initiatives to solve these problems

Its actions are based on **UN/CEFACT Recommendations** (and ISO standards) on international best practices and standards.








2 significative Results:










Operational structure of ITH-Italia


