SASEC Nodal Officials met at the sidelines of the 49th Annual General Meeting of the Asian Development Bank in Frankfurt, Germany, to discuss key achievements of the SASEC Program over the past 12 months and provide overall strategic guidance on future activities. Progress of the SASEC Program in the areas of transport, trade facilitation, and energy was actively discussed, and next steps decided for SASEC in 2016. Myanmar attended its first Nodal Officials' Meeting as a full member of the SASEC partnership, having formally joined in February 2017.

Electronic Cargo Tracking System to Improve India-Nepal Cargo Traffic and Security

6 June 2017: Mumbai, India

An electronic tracking system will soon ease traffic-in-transit for cargo traveling by road and rail from Kolkata to four major Customs points of Nepal, including the Raxaul route. Mr. Sandeep Kumar, Customs Commissioner, India, and Mr. Rabi Shanker Sainju, Commerce Ministry Joint Secretary, Nepal, signed a memorandum of intent to pilot the tracking system for a trial period of at least 90 days in late 2017.

India Drafts Cross-border Energy Trade Framework

28 May 2017: Kolkata, India

India's Ministry of Power is preparing a set of guidelines for cross-border trade of electricity, with draft regulations from the Central Electricity Regulatory Commission. This will regulate cross-border energy trade between India and Bangladesh, Bhutan, Myanmar, and Nepal, by creating a uniform framework.

24 May 2017: Dhaka, Bangladesh

Mr. Harsh Vardan Shringla, India's High Commissioner to Bangladesh reiterated India's commitment to remove nontariff barriers (NTBs) through the standard-setting bodies of India and Bangladesh. The Bureau of Indian Standards and the Bangladesh Standards and Testing Institution have begun cooperating on certification of goods, to resolve NTB-related export restrictions.

SAARC Market Holds \$24.65 Billion Potential for Bangladesh

Bangladesh export to the South Asian Association for Regional Cooperation (SAARC) region could reach \$24.65 billion by 2020, according to the UNESCAP report "Unlocking the Potential of Regional Economic Cooperation and Integration in South Asia." Bangladesh's unexploited potential for exports to SAARC region is estimated at 93%.

India Begins Work on Myanmar Road for IMT Trilateral Highway

17 May 2017: Guwahati, India

India's National Highways Authority has begun upgrading the 120-kilometer Kalewa-Yargi road in Myanmar's Sagaing region. It will connect to Tamu, Myanmar, which links to Moreh, India, through a 130-km stretch of road. These roads are part of the of the India-Myanmar-Thailand Trilateral Highway, which runs from Moreh to Mae Sot (Thailand), passing through Myanmar.

WTO Trade Facilitation Committee Convenes First Meeting in Geneva

16 May 2017: Geneva, Switzerland

The WTO Committee on Trade Facilitation met for the first time on 16 May 2017 in Geneva, Switzerland. The Committee was formed to oversee the implementation of the WTO Trade Facilitation Agreement and is tasked to provide a forum for WTO member countries to consult on operationalizing the TFA.

15 May 2017: Dhaka, Bangladesh

A delegation of the India-Bangladesh Chamber of Commerce and Industry (IBCCI) met with Mr. Shajahan Khan, Shipping Minister, Bangladesh, to discuss trade bottlenecks in Bangladesh-India land ports. Infrastructural and administrative bottlenecks in land and sea ports of Bangladesh and India slows down the trade process. Long delays for trucks to pass through Customs, for example, results in shortages of warehouses and trucks, and skyrocketing prices in truck rentals.

14 May 2017: Kolkata, India

A conference organized by the Delhi Policy Group discussed how to improve the trade and investment environment in the Bangladesh, Bhutan, India, and Nepal (BBIN) subregion. Mr. Selim Reihan, Economics Professor, Dhaka University, and Executive Director, South Asian Network on Economic Modeling, a panelist, puts forward that BBIN should work on expanding trade in goods and services as a formal regional platform under the World Trade Organization to prompt tariff liberalization.

At the Haat of a Border

13 May 2017: Meghalaya, India

The border "haats" (rural markets) have become an additional means of livelihood for vendors from select border areas of Bangladesh and India. The haats have also allowed people from both countries to meet. This commentary, which originally appeared in the Hindu, provides a closer look at the impact of the border haats to the lives of traders and consumers at the border.

Bhutan's National Council Passes the Indo-Bhutan Trade Commerce, and Transit Agreement

12 May 2017: Thimphu, Bhutan

The National Council of Bhutan endorsed the Indo-Bhutan Trade, Commerce, and Transit Agreement on 12 May 2017, benefiting both countries by promoting a free trade regime, duty free transit of Bhutanese merchandise for trade with third countries through Indian ports; and additional entry/exit points for Bhutan's trade with other countries. It also promotes periodic exchange of trade data.

India has signed investment agreements worth \$31 million at the Integrated Transport and Logistics Summit in New Delhi, India. The agreements form part of the Government of India's holistic approach to spur infrastructure growth, according to Mr. Nitin Gadkari, Road Transport and Shipping Minister, India.

The Bangladesh-Bhutan-India-Nepal (BBIN) Motor Vehicles Agreement (MVA) will be redrawn by Bangladesh, India, and Nepal, following Bhutan's agreement for the three countries to proceed with its implementation. In June 2017, the BBIN working group will meet to redesign the routes.
