ADB Approves \$1.5 Billion Railway Project for **Bangladesh**

29 September 2016: Manila, Philippines

The Asian Development Bank has approved a multitranche loan of \$1.5 billion to the Government of Bangladesh for construction of a key section of the Chittagong-Cox's Bazar railway line—the largest ever investment in railways by ADB. The new line will improve Bangladesh's access to Myanmar and beyond, facilitate trade, and boost tourism in southeastern Bangladesh.

ADB to Fund India's First Coastal Industrial Corridor 29 September 2016: Manila, Philippines

ADB has approved a multitranche financing facility and grant of \$500 million for the Visakhapatnam-Chennai Industrial Corridor Development Program to develop India's first coastal industrial corridor, with the Government of India also contributing \$215 million in funding. The Visakhapatnam-Chennai Industrial Corridor is a key section of India's planned East Coast Economic Corridor that will spur development on the country's eastern coast and create seamless trade links with other parts of South and Southeast Asia.

Nepal Parliament Ratifies Protocol of Amendments to the Revised Kyoto Convention

9 September 2016: Kathmandu, Nepal

The Nepal Parliament ratified the Protocol of Amendments to the International Convention on the Simplification and Harmonization of Customs Procedure (Revised Kyoto Convention) on 9 September 2016, tabled by Mr. Krishna Bahadur Mahara, Nepal Deputy Prime Minister and Finance Minister. The ratification is expected to boost the capacity of Nepal Customs to facilitate trade.

India Sets IMT Trilateral Highway Completion 9 September 2016: Vientiane, Laos

The India-Myanmar-Thailand (IMT) Trilateral Highway is set to be completed by 2019-2020. India Prime Minister Narendra Modi has assigned the India Ministry of External Affairs to monitor and oversee its completion. Prime Minister Modi also proposed creation of a joint task force on connectivity comprising India and ASEAN members. The IMT Trilateral Highway will link South and Southeast Asia, starting from India's Moreh City in Manipur, passing through Myanmar's Tamu City, and continuing up to Thailand's Tak Mae Sot.

Bangladesh Forming a Hydropower Generation Company 9 September 2016: Dhaka, Bangladesh

The Government of Bangladesh plans to form a hydropower generation company to import hydropower from countries including Bhutan and Nepal. The initiative will be set up under Bangladesh's Power Division, Ministry of Power, Energy, and Mineral Resources. The company's memorandum of association and articles of association will soon be formulated. A trilateral meeting was set among Bangladesh, Bhutan, and India in October 2016.

Bangladesh to Sign FTA, Coastal Shipping Deal with Sri Lanka 5 September 2016: Colombo, Sri Lanka

Bangladesh is set to sign a free trade agreement and a coastal shipping deal with Sri Lanka to boost trade and investments between the two countries. A Joint Study Group will be formed to accelerate development of the coastal shipping agreement, for which standard operating procedures are being drafted.


